The University of California, Irvine (UCI) is excited to announce that the [UCI chapter of Phi Beta Kappa](#) received the Outstanding Public University Chapters award from the [Phi Beta Kappa Society](#) at their 46th National Triennial Council meeting. Held every three years, this year's event took place August 3rd-6th and drew Phi Beta Kappa executives, senators, and chapter and association representatives.

The UCI Phi Beta Kappa chapter was recognized in front of hundreds of faculty and college administrators by Calvin Van Niewaal, Chair of Phi Beta Kappa's Committee on Chapters. Recipients of Outstanding Chapter Awards demonstrate extraordinary accomplishment in key areas like student outreach and chapter visibility. UCI's chapter received this honor for its success with first-generation students as well as its high acceptance rates among students offered membership. This prestigious award included a \$500 contribution to support the UCI chapter's ongoing work.
